Standard Terms and Conditions:**Do Not return this Form !!!!**

Exhibitors are responsible to secure their own exhibits while on the show grounds. The East London Agricultural Society and the Gonubie Farmer's Hall Committee will not be held responsible for any loss or damage to exhibits. Security guards will be on patrol.

All Health & Safety standards must be adhered to and hygienic conditions are very important. We will not tolerate any unhygienic conditions and your site must be kept clean and attractive at all times, should we find it to be unhygienic we will have no alternative but to close you down. City health Requirements as per regulation 638.

No flammable substances may be kept at your stand unless by special arrangement and with the necessary fire and safety equipment. Fire Extinguisher of correct size, serviced and for the appropriate fire must be on your stand. (Fire Brigade Services Act)

Electrical supply point will be available at a cost, see application form for details. **Should you use more than one plug point at your stall end it will cost an additional R50.00 per item.** All leads and plugs to be supplied by stall holders and must be in good order AND NOT be Less than 2.5 mm. **The EL Show Committee is not Responsible to Supply Electricity should ESKOM Load shedding take place during the EL SHOW period.**

Generators will not be allowed within the Trading Zone's. They will have to be RUN from a designated area as per EL SHOW Committee. Rules & Regulations Apply.

Please note that **all stands are approximately sized.** (Please take tent ropes into account when requesting your stand size. Your stall may not go over the requested size including the tow bar.

Included in the stand price are 2 arm bands (Valid for the duration of the show) for persons manning the stand/stall. **Should you have more helpers you need to purchase additional armbands which will be available** from the convenor for either the duration of the show or per day at the entrance gate. No pass outs will be given during the day. Should you have someone taking over your stall they would have to pay before entering if they do not have an entrance ticket.

All exhibitors must keep their exhibits intact for the duration of the show I.E **until 16h00 on the 3rd May 2026. NO EXIBITORS WILL BE ALLOWED TO LEAVE BEFORE THIS.** No refund will be paid for cancelled bookings. Exhibitors will **ONLY be ALLOWED to leave the grounds at 17h00. Safety of visitors to the show to be taken into consideration.**

Exhibitors must supply their own materials (tables and chairs) and must confine their exhibit within the area allocated to them. Power extension leads and lighting for stands to be supplied by exhibitors, and must be in a serviceable condition, as per the O.H.S. Act.

SET UP: Wednesday 29 April. Show hours from Thursday : 08h00 – 18h00, except the last day when the show will close at 16h00. **Pack up only to start then at 16h00 on the last day. Gates will be on lock down for all vehicles and will only open at 17h00.**

No vehicle movement will be allowed for the duration of the show, except emergency and service vehicles. Gates will be locked at 06h00 on the 30th April. The conveners decision will be final and non negotiable. Vehicles parked in No Parking areas will be towed away. Vehicles may be parked in the main parking area or allocated exhibitors parking area.. (As stipulated in ACT 2/2010 Safety at Sports and Recreational Events.) A R100.00 fine will be charged should it be towed away as well as the relevant towing costs.

Staff will be made available to help carry goods to stall from a designated drop of point. This service will ONLY be for day to day requirements and not complete stalls. Please don't leave everything to the last minute as you will have to wait in a queue for help. Please note that no exceptions will be allowed.

No Dangerous weapons will be allowed on the premises. (Dangerous Weapons Act)
NO BB GUNS, STUN GUNS or similar weapons may be sold.

These terms and conditions are non negotiable. By your signature on the application form you agree to abide by these conditions and agree that you represent all persons working at or operating the stall applied for. No stand will be made available if the form is not signed.
